

CLOSING ARGUMENT

For Alexander T. Wolf

Claimant: The Three Little Pigs' Smartest Brother

Ladies and gentlemen of the jury, I implore you to cast your eyes upon Mr. Alexander T. Wolf, an animal that has clearly been misunderstood and misjudged throughout all of fairytale land. Yes, wolves may live in the wild, eat *very* small critters, and even scare small children with their loud voices, but that is merely a generalization; none of these statements...and I mean *none* of these statements are true of this fine upstanding citizen of the forest.

I believe you will find that it is quite clear that the prosecution has not proven its case against Mr. Alexander T. Wolf. They did not present enough evidence to prove that he is guilty of either of the two counts of second degree murder.
